Salaam CAMBA Members: I currently work an Adjudications Officer with USCIS. I previously worked at the Office of the CIS Ombudsman, where I engaged in stakeholder outreach, assisted applicants with issues related to USCIS, and assisted in drafting policy recommendations to help improve immigration services by the agency. I also had the unique opportunity to serve as an Asylum Officer with USCIS. Prior to being employed with the federal government, I was managing attorney at a boutique immigration law firm in New York City, where I represented individuals from all walks of the world. I have also served as an active participant within the immigrant and American-Muslim advocacy communities in NYC, rallying around various issues such as voter rights; hate crimes backlash; community organizing skills; civil rights; and knowyour-rights education tools.

I moved to D.C. from New York not too long ago, and each interaction with CAMBA Board representatives and members has been welcoming. I realized this organization is just as passionate as I am about having a positive impact in the legal community and creating a professional space for the growth of American Muslim lawyers. Similar to the volunteer nature of this bar association with all hands on deck, MuBANY Board members brain stormed and hosted events that were relevant to the needs of our member-base and legal community at the time, such as: women's round tables; career growth in the various legal sectors; summer mentorship and bar exam review; bias faced by members of various faiths; and diversity & inclusion. We partnered with many minority bar associations, and at times I served as a liaison and representative of MuBANY. This was all in addition to our designated Board roles. My name is Jesmin Saikh. I currently serve as an attorney with the Board of Veterans Appeals, an agency within the United States Department of Veterans Affairs. Prior to joining the Board of Veterans Appeals in 2015, I practiced immigration law with a nonprofit organization in Columbia, Maryland. I am currently a member of my agency's Diversity and Inclusion Committee, and have trained attorneys that are new to my agency. I received my J.D. from American University's Washington College of Law in 2012, where I was a member of the Moot Court Honor Society and Immigrant Justice Clinic. I am licensed to practice law in the state of Maryland. Prior to law school, I attended the University of Maryland, College Park, where I completed separate degrees in cell biology and molecular genetics, and government and politics.

I want to join the CAMBA Board because I personally have benefited from being a part of the organization, and I would now like to assist the organization in furthering its objectives in the upcoming year. I began attending CAMBA programs and events in 2013, when I was a recent law graduate. CAMBA provided me with a platform to meet and interact with Muslim attorneys in diverse fields. Through these interactions, I was able to receive valuable guidance from more established practitioners regarding my career. I was also able to establish my own network of relationships with other entry-level attorneys, and to this day, we continue to provide support and assistance to one another in our respective careers. Thus, because I have benefited immensely from CAMBA, I want to assist the organization in continuing to provide a meaningful platform for other Muslim attorneys in this area.

The most valuable qualification that I bring to the CAMBA Board is my prior experience working with CAMBA. Since 2017, I have been a part of CAMBA's mentorship committee, and have assisted in developing the current mentorship program. In addition to assisting with the creation of the program, I've specifically assisted in developing materials for the program, and assisted in locating and pairing prospective mentors with their mentees. I also assisted CAMBA by serving on a panel for its Mock Interview and Resume workshop this past April, and have provided logistical support during CAMBA's most recent Iftar Dinner. I also work well on a team, and would be able to smoothly integrate within the existing Board. Finally, one of my strongest skills is that I am goal-oriented, which will assist CAMBA in achieving the specific objectives it has set for the upcoming year.

I envision two specific goals for CAMBA this year. First, I would like to strengthen and expand CAMBA's existing mentorship program. At the moment, we have facilitated individual mentormentee relationships on a smaller scale. The mentorship committee has discussed organizing monthly meetings for larger groups based upon practice area, so that experienced practitioners can meet with newer attorneys looking for guidance in that specific practice area. As a Board member, my goal would be to ensure that we provide this type of mentorship platform. My other goal for CAMBA is to expand its membership base. There are many Muslim attorneys working in the area that are unaware that an organization like CAMBA exists. In the past two years, CAMBA has organized popular events, such as an event with the Washington State Solicitor General who challenged the travel ban, which have attracted a diverse group of attorneys. As a Board member, I would assist the existing Board in organizing programs such as these in order to engage other Muslim attorneys who are not yet involved with CAMBA.

I will conclude my application by expressing that I feel an immense amount of pride to be a part of CAMBA. When I was growing up, I did not come across many Muslim attorneys, especially female Muslim attorneys. Now, in my agency alone, I work with at least 10 other Muslim attorneys. Most of these individuals I met through CAMBA. Through CAMBA, I've had the opportunity to meet other attorneys who are at the forefront of their respective practice areas, and are poised to become leaders in their field. This has encouraged me to try and achieve more in my own career. Becoming a CAMBA Board member would provide me with the opportunity to play a greater role in an organization whose growth I am committed to.
